August 1968--Madison, WI

First Council Meeting

1. A 6% and 4% increase in page rates for printing in 1969 and 1970 was adopted.

2. The standing Committee on Fellows was requested to review the existing qualifications for the status of Fellow, keeping in mind that Fellowship should be conferred on members who have demonstrated distinction.

3. A recommendation of the Committee on Operations that the IMS should be involved in sponsoring Summer Institutes was adopted.

4. Following the report of the Nominating Committee, a motion to show the present affiliation of each nominee and to give each candidate a choice as to how his name appears on the ballot was carried.

5. A report of the Committee on the Directory of Statisticians which listed complaints and suggested changes was sent to E M Bisgyer of ASA who will manage the combined membership list.

6. The report of the Committee on Exchanges of the <u>Annals</u> was accepted including the specific recommendation that IMS discontinue all exchanges at the close of the 1968 volume, and that journals received in exchange for the <u>Annals</u> be retained permanently or disposed of.

A motion that the IMS volunteer to underwrite up to \$1000 more, if needed, the activities of the Committee on Classical Articles and History of Statistics was accepted.
 8. The IMS support of the Mathematical Offprint Service was approved by mail ballot.

9. The <u>ad hoc</u> committees on Visiting Lecturers in Statistics and on Movies of Lectures was to be continued, and a new Managing Editor to be nominated; the remaining <u>ad hoc</u> committees were discharged.

Business Meeting

1. The IMS was not making direct representations concerning the military draft as it affects graduate students and younger faculty members, but was cooperating with the Conference Board of the Mathematical Sciences and COPSS in joint representations of the Mathematical and Statistical Societies.

Second Council Meeting

1. A motion that Katz and Resnikoff maintain liaison with Bisgyer of ASA regarding the <u>Directory of Statisticians</u> was accepted.

2. A motion that the Executive Secretary prepare a certificate of fellowship in IMS for presentation to all present and future fellows was approved.

3. A motion for the President and Executive Secretary to prepare and circulate to Council members and appropriate authorities a letter regarding the draft was accepted.

4. Delinquent members were deleted from membership rolls.

5. A motion to authorize up to 2200 pages for the 1969 Annals was accepted.

6. A motion that the Managing Editor print only abridged programs of IMS meetings was approved.

7. The Managing Editor will resume the publication of lists of theses in Probability and Statistics, including those of the last year which had been deleted.

August 1969--New York City, NY

First Council Meeting

1. A motion for the Council to re-affirm its previous motion "that the Standing Committee on Fellows be requested to review the existing qualifications for the status of Fellow, keeping in mind that Fellowship should be conferred on members who have demonstrated distinction" was carried.

2. The incoming President is to appoint a committee to make specific recommendations on appropriate use of the Hotelling, Dorweiler, and similar gifts which may be received by IMS in the future.

3. A motion to replace the existing Committee on Summer Institutes by two committees; one on Summer Research Institutes, and a second on Summer Teacher's Institutes was approved.

4. The Committee on Movies of Lectures was formally discharged.

5. The President moved that IMS appoint a liaison committee with IASPS to make some joint arrangements for meetings in 1971 in connection with the ISI meeting in Washington, DC.

6. An <u>ad hoc</u> committee to pursue actively the issue of NSF's arbitrary cuts of last year and possible in the future will be appointed with representatives to COPSS and to CBMS to assist in this matter.

Business Meeting

1. A motion not to meet in the Statler-Hilton again due to discontent with hotel reservations, etc., and that this sentiment be conveyed to the AMA was passed unanimously.

Second Council Meeting

1. The Council directed that its delegation to the ISI meeting inquire about the relationship of IMS members to ISI, in view of the possible forthcoming ISI meeting in Washington. Appropriate recommendations to the Council will be made.

2. The Council adopted the policy that in the long run, annual meetings be held half with AMS and half with ASA.

3. The Managing Editor and Program Secretary will constitute a committee to make recommendations regarding deadline dates for acceptance of contributed papers, styles of printing, preprinting, etc.

4. Noting that the terms of office of the present Executive Secretary and the present Treasurer expire in 1970, a motion that the President approach the present officers with a view to continue for another term, and if necessary, appoint a committee to search for new officers was passed.

5. Until the Council had final information from ASA regarding a proposed insurance scheme sponsored by ASA, a motion to not take action on the current insurance enterprise was carried.

6. A motion that all material published in the <u>Annals</u> be copyrighted in the future was carried.

7. A motion that the Council approve adoption of rules for submission of manuscripts similar to those of AMS and that the President appoint a committee to formulate appropriate rules was carried.

8. The Council approved publication of 2200 pages for the Annals

in 1970.

9. The Council authorized the Committee to Recommend a New Editor for the <u>Annals</u> to investigate whether the duties of the Editor require changes in the structure of the editorial staff and facilities.

10. The Council instructed the Managing Editor to investigate alternative publication possibilities and make recommendations for further action.

11. A motion that the exchange publication of lists of contents of journals be left in the hands of the Managing Editor was carried.

August 1970--Laramie, WY

First Council Meeting

1. The Council agreed with the Treasurer that the dues be kept where they currently are for the next year.

2. The Committee on Operations was to make suggestions to provide additional services to members.

3. The Council approved a "reasonable severance pay" to Resnikoff's secretary at the end of his office term.

4. The Treasurer is authorized to continue his present policy of investing in US Government obligations, eschewing mutual funds.

5. The publisher requested an increase in price to compensate for added costs of typesetting in the first volume of the Mathematical Tables. The Council approved that the co-chairman of the Committee on Mathematical Tables negotiate a lump-sum settlement for these costs, not to exceed \$1500.

6. The Council accepted two recommendations by the Committee on Individual Membership to recruit new members (report no longer on file).

7. The Council approved preparations of an "automated" author index with a committee to be appointed by Kruskal to proceed under a cost limitation of \$2000.

8. A committee is to be appointed to experiment with a subject index and with an index of the Steenrod-type based upon the Mathematical Reviews, and a classification system. 9. The Council approved that \$5000 be made available in advance to the Visiting Lecturer Program annually and request ASA to agree to a \$2500 annual advance as a matching contribution to freeing the program from delays.

10. Since the like insurance plan for members of the Institute has been approved by mail ballot of the Council, it was further approved that a settlor's agreement by signed by Jack Kiefer, acting for the IMS.

Business Meeting

1. A move was made to reconstitute the National Committee on Statistics under NRC auspices.

2. A motion that the membership go on record to encourage the President and Council to seek means to broaden the scope of the Institute, and to ensure greater participation by members in some of the subfields of mathematical statistics was approved unanimously.

Second Council Meeting

1. The Committee on <u>Annals</u> reorganization was to continue work along present lines and to solicit reaction from the memberships.

2. The Council asked the Hall Committee to consider and recommend an appropriate time to appoint a search committee for the new editor called for under the restructuring plan.

3. The Council authorized the Treasurer and Managing Editor to enter into negotiations with Waverly in the behalf of IMS for publication of the <u>Annals</u>.

4. A motion that the funds received as a bequest from the Dorweiler estate and from the Gift in honor of Professor Hotelling be placed in reserved funds, name respectively the Dorweiler Fund and Hotelling Fund, and that the principal and any income earned by these funds be used for the aims and purposes of the IMS was passed.

5. The President appointed members to the Committee on Individual Members to revitalize it by developing routine procedures which may be effectively carried out from year-to-year. 6. The Council decided that the Treasurer will issue membership address lists annually.

7. Because of the increasing numbers of contributed papers, it was moved and carried that the deadline for submission of papers for each meeting be changed from 50 days to 60 days in advance of the opening of a meeting.

8. Regarding election procedures, it was moved that polls close at noon on the first day of each Annual Meeting.

9. The Council approved continued discussions by Kruskal regarding a National Committee in Statistics under the auspices of NRC.

10. It was moved and carried that IMS should extend indefinitely its policy of cooperation with MOS.

11. The Council authorized 2250 pages for the 1971 Annals.

12. A motion that the Council recommend to the Nominating Committee that no man be nominated to serve on the Council who has served in this capacity in the previous six years was carried.

13. In order to recognize the effort of many members in serving on committees and to provide a means for all members to communicate their thoughts to specific working committees of IMS, the Secretary was directed to prepare full lists of committee members who served in the past year, and a list of new committee chairmen for the new year.

August 1971--Fort Collins, CO

First Council Meeting

1. The Committee on Summer Research Institutes reported that NSF has no funds available and consequently will not be in a position to support Research Institute for 1972. There is some hope for support either from NSF or alternative sources in the fall of 1972 on a modified basis.

2. The Council accepted the decision of the Markham Publishing Company not to continue publication of <u>Selected Tables in</u> <u>Mathematical Statistics</u> beyond Volume I.

3. Authorization was approved for secretarial and organization expenses up to \$500 per year.

4. It was decided to offer space in the <u>Bulletin</u> for purposes of disseminating news regarding the European Region.

5. The Council agreed to extension of its underwriting of support through 1972 if the NSF grant for that period should be inadequate.

6. On recommendation of the IMS representatives, and after examination of the CBMS constitution to verify that objections of some european members had been removed, the Council had voted by mail to accept this document.

7. The report of the IMS Committee on Restructuring the <u>Annals</u> was approved by the Council with modification of item 4, relating to costs of people buying one or both journals. (Report no longer on file.)

8. A series of motions by the Treasurer were accepted leading to a cost structure as follows:

*Retired members may elect to receive the <u>Bulletin</u> only at \$1 per year.

**Institutional members and designees with privileges of membership will receive both journals but no bound copies will be supplied.

Executive Meeting

1. Extra reprints of the 1971 index would be available to anyone on a first-come, first-serve basis, upon the receipt of a preaddressed, stamped envelope.

2. A discussion was opened concerning a proposal to create a second journal (<u>Annals of Probability</u>?). It was agreed that a questionnaire sent to members should make it clear that this division would almost certainly lead to parallel boards of editors producing alternate issues with emphasis in probability and in statistics, respectively. It was also agreed that this

questionnaire would indicate that a member who elected one journal would have a slight decrease in dues, while those who elected both journals would have a slight increase in dues.

3. It was agreed that the News and Notices would be handled by retyping authors' material and using a photo offset process. Additionally, it was agreed that this publication would include abstracts of papers, News and Notices material similar to that now in the <u>Annals</u>, statements about meeting plans, lists of new members, annual reports, etc.

4. It was decided to proceed with the News and Notices publication assuming the figures on costs of production are favorable.

5. The Institute will submit a proposal for a Visiting Lecturers Program in India, involving Indian and/or American lecturers traveling around to some of the universities in India.

6. A motion that every IMS Fellow, resident in the US, be in Who's Who in America, with similar action initiated for Fellows resident in other countries.

Business Meeting

1. The Treasurer requested cooperation from all members in overcoming the alarming decrease in the number of student members.

Second Council Meeting

1. A motion that the new <u>Bulletin</u> be used as a vehicle for announcements of meetings and notes of general interest regarding the European Region was accepted.

2. The AMS requested a cash contribution to the <u>Mathematical</u> <u>Reviews</u> in annual amount of one percent of the amount spent on primary publications. Since the cost of production of the <u>Annals</u> was approximately \$80,000, the contribution to the <u>Reviews</u> would be \$800. A motion to table a decision until further information was available was passed.

3. A motion that the IMS pay a "once only" page charge of \$125 to \$150 for inclusion of the list of officers and council member of the IMS in the AMS 1972 <u>Administrative Directory</u> was passed. The Executive Secretary was to communicate to the AMS that they should take steps to make the <u>Directory</u> self-supporting by its primary users, or give it up. 4. The Council adopted a resolution requiring the Program Secretary to obtain much more detailed information regarding the arrangements and costs of meetings before asking for Council approval.

5. The Council authorized 2200 pages for the Annals for 1972.

6. It was moved and passed that an <u>ad hoc</u> publications committee be set up to deal with problems of transition from the single journal to the two technical journals and the News and Notices publication.

7. Regarding the orderly transition from one journal to two, a motion that 1) the Executive Secretary propose to the Council necessary changes in the Constitution to minimally effect the editorial changes, 2) the same procedure be used to effect dues changes, and 3) the President appoint a five member committee to consider a thorough revision of the Constitution, was passed.

8. The Council decided that life members should get both journals free of additional charges.

9. The Council approved a motion that the President appoint an <u>ad hoc</u> research committee to investigate and make recommendations concerning present and alternative printing arrangements.

10. The Council adopted a Resolution to the effect that all financial negotiations shall be the responsibility of the Treasurer.

11. A motion for the Council to reconsider the subscription rates for the journals was passed.

12. A motion that the Council adopt a Resolution governing handling of funds of the Institute in accordance with the following rules was adopted by the Council:

1) No bank accounts may be established in the name of the IMS except by specific authorization of the Council.

2) The Treasurer may be, but need not be, the sole signer for the Institute checking account, unless the Council directs the requiring of additional signatures.

3) Institute checking accounts shall not contain funds in excess of an amount designated by the Executive Committee.

 Except for the checking accounts, all transactions involving money, securities, or savings accounts shall require at least two signatures designated by the Executive Council.

5) Whenever circumstances shall require a change in the designation of person(s) who may be authorized to sign for the Institute in any fiscal matter, the manner of effecting such change must include the written authorization of the president.

6) The Council shall seek to have these resolutions enacted into the by-laws.

13. The Council will appoint an <u>ad hoc</u> committee to consider the question of cutting costs of publications, especially for students.

August 1972--Hanover, NH

First Council Meeting

1. The Council voted tentatively to subsidize up to \$4000 of a Visiting Lecturer Program for 1972-1973, restricted to a total budget not to exceed \$8000, subject to the condition that both the ASA and the Biometric Society underwrite an additional \$2000 to guarantee the total budget.

2. The Council approved payments of travel expenses to D Cox in order to make possible his appearance as Rietz lecturer at the next annual meeting in New York City; it was stressed that this action was taken because of special circumstances and would not constitute a precedent.

3. The Council adopted lengthening the period for construction of programs by adjusting the deadline dates for contributed papers to up to 90 days before the opening of the meeting.

4. Deadlines are to be published in the <u>Bulletin</u> with the understanding that each meeting shall contain one session for late papers whose titles and authors will not appear in the printed program.

5. Abstracts for papers submitted before the deadline date will appear in the <u>Bulletin</u> available at the meeting; late abstracts may not appear until a future issue of the <u>Bulletin</u>.

6. The Treasurer and the Chairman of the Publication Committee will take appropriate steps towards revision and preparation of a new brochure "An Introduction to the Institute of Mathematical Statistics".

7. The Council approved 2400 pages for the two journals, <u>The</u> <u>Annals of Statistics</u> and <u>The Annals</u> of Probability.

8. The Council adopted a resolution to delete the name of D J Finney from the list of Fellows of the Institute since an error was made in the past when he, who was never a member of IMS, was elected.

9. The Council approved giving authority to the Committee on Tables to try to publish more volumes in the Table series jointly with the AMS firstly; if that were not possible, the Committee should try a similar arrangement with ASA; and lastly, consider a commercial publisher.

10. The Council approved a motion that Professor Gani be named Associate Secretary for the European Region for the usual three-year term, and that his office be provided a subvention in the amount of \$500 per year to be used in carrying on the affairs of the European Region.

11. The President directed the Committee on Memorials to make recommendations on the publication of a Collected Papers volume of Savage's publications, particularly whether it should be a volume of selected papers as opposed to a volume of collected papers.

12. The Council approved a standing Committee on Memorials of at least five members representing diverse areas of interest. In addition, the committee should contain editors of the <u>Annals</u> as voting members, and as ex-officio members, the IMS Program Secretary, the Chairman of the Special Papers Committee, and the Chairman of the Committee on Gifts and Bequests.

13. The Council agreed that the <u>Annals</u> Index be published covering the entire period of publications of the <u>Annals</u> through the end of 1972.

14. The Council voted to approve the arrangement for the Visiting Lectures Program for the 1972-1973 year such that the IMS will contribute \$4000 for the purpose, provided that ASA contributes an additional \$2000 and the two Biometric Societies come up with another \$1200.

15. A second resolution regarding the Visiting Lectures Program said to the effect that <u>if necessary</u>, the IMS should increase its contribution to the program to \$4,800 in order to keep the total program budgeted at \$8000 was passed. 16. A motion that the Treasurer be authorized to create an endowment fund for Gifts and Bequests as well as a standing Committee on Gifts and Bequests to be created, was adopted.

17. A motion that the Editor of the <u>Bulletin</u> include an announcement regarding the H Hotelling Fund was accepted.

18. The Council endorsed the principle of awarding prizes named in honor of deceased distinguished leaders of statistics, including a named Award for the most innovative paper and another named Award for the best expository paper.

19. The Council voted to drop IMS representation of the subcommittee of CBMS on International Cooperation in Mathematics Education.

20. The Council voted to nominate W Kruskal to the CBMS committee which is to identify one or more specific matters that might fruitfully be discussed with OMB, to develop specific suggestions that might be conveyed to OMB, and to recommend to the chairman a format for the possible meeting.

Business Meeting

1. A special circumstance led to the presentation of the ballot form about 15 days before the deadline for submission of additional nominees for Council as specified by the constitution. A motion to accept this procedure as an exception to the constitution was carried. The President ruled that no effective nominations in addition to those made by the nominating committee were received before the 45-day deadline and that as a result, the election procedure was valid.

2. Due to the objection to printing at the end of each paper the address of the main author of each joint paper, the Council agreed that the Editors would try to develop some method of avoiding the singling out of one author as though more important than others.

3. A motion that negative remarks regarding the previous administration of the Treasurer's Office be deleted, the resolution as modified was published in the Bulletin.

4. The replacement of <u>The Annals of Mathematical Statistics</u> by the two new <u>Annals</u>, which led to constitutional amendments, was approved by the membership in a mail ballot.

5. Other actions implemented the establishment of the <u>Bulletin</u>, the transfer of certain material previously appearing in <u>The</u> <u>Annals of Mathematical Statistics</u> to the pages of the <u>Bulletin</u> along with material previously issued by the office of the Executive Secretary.

6. The tentative revision of the by-laws Article 2 (Dues) as approved by the 1971 business meeting had been slightly modified as to wording, but not as to content, and would appear in the Constitution as amended through August 1972.

Second Council Meeting

1. The Council approved the payment of approximately \$800 in the current year of the <u>Mathematical Reviews</u>, and to instruct the Committee on Operations to consider whether additional subventions to the AMS for financial difficulties involving the <u>Mathematical Reviews</u> could be made.

2. The Council authorized the payment of an amount to be determined by LeCam for the travel expenses of Professor Dvoretsky in appearing at the Dartmouth meeting.

3. The Council approved a motion that the Editor of the <u>Bulletin</u> should decide in each case whether to accept an advertisement on the basis that it was of possible professional interest to members of the Institute.

4. The President would work toward appointing certain committees in advance of the next Annual Meeting in order that they might arrange to hold meetings in person. Such meetings would avoid programs which were largely structured by one man.

5. The Council authorized a standing rotating-membership Search Committee for Editors. A further motion that this committee consist of at least six members for staggered terms: two appointed for three years, two more appointed for two years, and two appointed for one year, was approved.

6. The Council adopted a motion that a parallel committee be appointed to search for the administrative officers.

December 1973 -- New York City, NY

First Council Meeting

1. The Treasurer indicated an increase in expenditures due to splitting the <u>Annals</u> into two. Therefore, he requested conservatism in planning new expenditures and presented the Council with a proposed budget. 2. A motion that IMS contribute \$2000 to provide for some honoraria for senior scholars was passed.

3. The motion to separate the offices of Secretary and Editor of the <u>Bulletin</u> was approved via mail.

4. The Council approved a single standing Committee on Investment and Finances whose function would be advisory to the Treasurer and Council.

5. A recommendation of the Committee on Operations that matters relating to budget and short-range finance should be handled by the Council as before, was also accepted.

6. The Council approved support for the <u>Mathematical Reviews</u> in the amount of \$850.

7. A proposal for joint publication of the Series on Tables with the AMS handling publication details and distribution had been approved by the Council.

8. The Council voted approval of a further \$500 subvention to the European region to cover its secretarial and informational activities.

9. A motion to sponsor the Annals Index project was approved.

10. The Council approved the proposal that the IMS would contribute 50 cents per member to the Visiting Lecturer Program, and that other societies would contribute 25 cents per member.

11. All societies will contribute to the republication of the brochure "Careers in Statistics". The total cost of the brochure will be \$20,000 of which IMS will contribute 19% on a proportional per member basis.

12. It was agreed that the responsibility for publication of the Fisher Lecture Series was in the hands of ASA.

13. The Council voted to request that the representative to the Division of Mathematical Sciences of NAS-NRC look after the interests of the IMS diligently.

14. The policy statement that the IMS should not accept joint sponsorship of any meeting in which it had not played a principal role in the planning and organization from the outset was adopted.

15. An <u>ad hoc</u> Committee on Applied Probability will be appointed to cooperate with the informal committee for conferences on stochastic processes was approved. This committee would investigate and report to IMS possible arrangements for continued cooperation with CCSP.

16. The Council reaffirmed the existing policy of IMS not to provide for expenses of representatives to associate organizations.

17. The Council asked Puri to re-examine the feasibility of conducting a successful research institute within the limits of the NSF budget and return to the Council, if necessary, with a revised budget without provision for stipends for speakers.

Business Meeting

1. On recommendation of the Committee on Operations, the Council ordered that the functions of the Executive Secretary and that of the <u>Bulletin</u> Editor be separated.

2. The Council agreed that the Institute would pay the travel expenses of the Wald Lecturer and the Rietz Lecturer but only when necessary and not as a matter of course.

Second Council Meeting

1. A motion that several complaints which had been received concerning the <u>Annals</u> be referred to the Committee on Publications was passed.

2. The Council disapproves of the current Soviet offer to reproduce the <u>Annals</u> and authorizes the Treasurer to continue negotiations, keeping the Council informed at every stage.

3. Biographical materials are to be included in the annual ballot. The Executive Secretary is requested to prepare the format of such biographical material and to submit it to the Executive Committee for its approval.

4. The Executive Secretary is requested to contact COPSS in order to explore the possibility of producing a roster of women statisticians, and a roster of minority statisticians.

5. The Executive Secretary is requested to contact J Neyman and E Scott to ask them to prepare a statement concerning the participation of statisticians in studies on the effect of pollution on health, this statement to be given to the Council for its consideration, for the transmittal to COPSS. 6. The Treasurer is authorized to charge the costs of printing as an expense in the year incurred.

7. The combined total pages for <u>The Annals of Probability</u> and <u>The Annals of Statistics</u> is authorized to a maximum of 2500 for each of the years 1974 and 1975.

August 1974--Edmonton, Canada

First Council Meeting

1. The Council approved a motion to allow the Program Committee for European Regional Meetings to elect its own membership, its Chairman, and its Associate Program Secretary, subject to review by the President.

2. The Council approved the recommendation of the <u>Annals</u> Index Committee that the IMS co-sponsor and contribute funds to support the development of a <u>Current Index on Probability and Statistics</u>.

3. The Council authorized the Executive Secretary to submit the amended draft Constitution to the members for a mail ballot.

Business Meeting

No action taken.

Second Council Meeting

The following resolution was adopted by the Council as IMS policy:

1) All deceased IMS members, and other colleagues designated by the Memorials Committee, should be remembered at a short memorial part of each Business meeting of the Institute, and a short obituary (biography) published in the Bulletin.

 This policy should be publicly announced so that information about deceased colleagues be promptly submitted to the IMS Secretary.

2. The Council voted to delete Article 6, which specifies the dues structure, from the draft version of the proposed revision the IMS by-laws.

3. The Council agreed that IMS members who subscribe through the

Treasurer to Biometrika be charged 50 cents for the service.

4. The President will appoint an <u>ad hoc</u> committee with the urgent charge to study the matter of increasing revenue for the Institute in order to meet expenses. This committee is to make timely recommendations on ways and means to cope with the continuing world-wide inflation and thereby avert deficit operations.

5. The Council approved of the following Resolution:

The IMS Council deplores the loss of academic freedom in Chile and urges all universities in North America and elsewhere to do all that they can to assist Chilean refugees to obtain professional employment in their disciplines.

August 1975--Atlanta, GA

First Council Meeting

1. After much discussion, the 1975 Council passed the following resolution:

Resolved to recommend to the 1976 Council that it adopt the following measures to increase IMS revenue:

b) Page charges to be \$20.00 per page.

c) Institutional memberships dues to be \$150.00

d) Registration Fees for IMS Meetings to be set at a level which will enable the Institute to recover all the direct cost to IMS of the meeting, with a special lower rate for students. 2. The Council approved as policy the recommendations favoring solicitation of advertising for the <u>Annals</u>, the giving of 50 free reprints to authors, and an increase in page charges.

3. The Council requested that the Treasurer study the impact on back issue sales of the recommendation to "...prepare collections of reprints from <u>The Annals of Mathematical Statistics</u>, <u>The</u> <u>Annals of Probability</u>, and <u>The Annals of Statistics</u> for publication in the form of short collections on a particular subject".

4. The Council agreed with the recommendation of the Publications Committee Report that the "Letters to the Editor" and "Problems" sections not be added to <u>The IMS Bulletin</u> at this time.

5. The Council approved as IMS policy the recommendation that the present policy of announcing the names of deceased members at the Annual Business Meeting be continued, and that <u>The IMS</u> <u>Bulletin</u> include brief obituary notices when appropriate and available.

6. The Council approved the continuation of IMS participation in the triennial Joint Directory with the proviso that COPSS should adopt a Biennial Joint Directory.

Business Meeting

No actions taken.

Second Council Meeting

1. Section B of the dues and subscription resolution presented in the First Council Meeting was amended to the following: The page charges will be 50% of the current print cost per page.

2. The Council voted not to consider either the Hall-Kemperman Resolution which had been referred by the 1975 Council, or the AAAS Resolution which had been introduced by Resnikoff.

3. The President will appoint an <u>ad hoc</u> committee to study the desirability of the IMS making special awards for outstanding papers written by younger members.

4. The Council approved that the <u>Annals</u> Editors be permitted to suggest to authors submitting papers that they send abstracts of

the papers to The IMS Bulletin.

August 1976--New Haven, CT

First Council Meeting

1. The President appointed an <u>ad hoc</u> committee to investigate the possible use of new developments in computerized typesetting.

2. The Council passed the following resolution:

The Institute establish and edit a continuing, flexible series of scholarly publications to include lecture notes, research monographs, expository surveys, etc. An <u>ad hoc</u> committee containing the Publications Committee to develop ways and means to implement this principle will be appointed.

3. The Council approved the following recommendations in the Report concerning the Hotelling Memorial Volume:

a) The present committee for the Hotelling Memorial Volume is dissolved.

b) The Publications Committee is authorized to search for a new committee to manage the preparation of the Hotelling Volume.

c) The Publications Committee is also authorized, in the interim, to discuss with other organizations the possibility of joint sponsorship of the volume.

4. The Council approved the recommendations of the Committee on Special Papers (report no longer on file).

5. The Council approved a Resolution on the Right of Access to participation at IMS Meetings.

6. The Council passed a Resolution to charge the Publications Committee with the task of studying the role and function of <u>The</u> <u>IMS Bulletin</u> and its costs, and to consider alternative means of discharging the Bulletin's functions.

7. The Council passed a Resolution to charge the Publications Committee, to begin, in conjunction with the IMS Treasurer, a study of ways and means to produce Indexes to <u>The Annals of</u> <u>Probability</u> and <u>The Annals of Statistics</u>. 8. The Council passed a Resolution to charge the Operations Committee to study the desirability and feasibility of making more permanent the location of the IMS Business Office.

Business Meeting

No action taken.

Second Council Meeting

1. The Council authorized a total of 2400 pages for the journals of the Institute for 1977: 1100 for <u>The Annals of Probability</u> and 1300 for <u>The Annals of Statistics</u>.

2. The Council agreed to reconsider its Resolution of Freedom of Access to Participation at Meetings. The following substitute Resolution was passed:

Because the IMS is responsible to an international membership, the Council adopts the following resolutions regarding the location and accessibility of IMS meetings.

a) In arranging its meetings, the IMS and the organizing committee for the meeting shall take all measures within their power to ensure each IMS member and invited speaker the fundamental right of participation.

b) If at any time prior to or during a meeting it is the judgment of the IMS President that the host country has denied any IMS member or invited speaker free access to the meeting by failing to grant a visa or by any other discriminatory act, he shall withdraw IMS sponsorship of the meeting and shall so notify the organizing committee and IMS members.

c) In the event of a meeting where possible access problems are anticipated, the IMS President shall request the organizing committee to inform the appropriate representatives of the government of the host country of the policies stated in paragraphs a) and b) above.

August 1977--Seattle, WA

First Council Meeting

1. In response to recommendations in the Report of the Committee on Operations, the Council passed the following motions:

a) The Executive Secretary is to inform the Administrative Officer Selection Committee that the Council requests the Committee to make every possible effort to find a new IMS Treasurer whose geographical location is in the San Francisco Bay Area.

b) Requested the Executive Secretary to charge the Operations Committee with the task of considering ways to reduce the cost of <u>The IMS Bulletin</u>, a specific suggestion being to investigate the possibility of assessing page charges for abstracts.

c) Requested the Executive Secretary to charge the Operations Committee with the task of recommending uniform procedures to be followed by the Committee on Fellows, including limits on the number of persons to be nominated each year.

2. In response the recommendations in the report of the Committee on Special Papers, the Council passed the motion that no speakers appointed by this Committee are to receive honoraria or travel expenses.

3. The Council voted to terminate the Committee on Gifts and Bequests.

4. The Council passed the following Resolution, to be transmitted to the Statistical Directory Steering Committee:

Resolved that the IMS Council urge the Combined Directory Committee to (1) drop the ethnicity questions from the questionnaire to be mailed with the directory information forms, and (2) indicate explicitly that answers to the remaining confidential questions are optional.

5. The Council noted that the failure to publish a complete and timely Nominating Committee Report was not due to either a deliberate or careless omission but was rather due to unfortunate circumstances. The Council then passed a resolution expressing its regrets to the Members, and declaring the 1977 Election to be legal.

Business Meeting

1. A motion to suspend the election rules for the 1977 election, declaring the election legal; this action should not be construed, however, as a precedent for future elections.

2. The motion that all speakers at meetings of the Institute shall be required to submit abstracts of their papers, was passed.

3. The motion that contributed papers are to be 10 minutes in length, with a 5 minute period between papers to allow for discussion, entrance and departure, was passed.

Second Council Meeting

1. The Council set the combined number of <u>Annals</u> pages for the calendar year 1978 to a maximum level of 2400 pages.

2. The Council requested that the Executive Secretary charge the Committee on Operations with the task of reviewing the process of appointment, terms of office, and duties of the Associate Secretaries, and related matters concerning Meetings Programs.

3. An <u>ad hoc</u> Hotelling Volume Committee was to arrange for the preparation of a Hotelling Volume.

4. The Council requested that the Executive Secretary inform <u>The</u> <u>IMS Bulletin</u> Editor that it wishes to have published from time to time in the <u>Bulletin</u> a schedule of world wide statistical society meetings.

August 1978--San Diego, CA

First Council Meeting

1. The Council requested the Executive Secretary to transmit to the 1979 Committee on Fellows for its consideration that part of the Report on Operations which deals with the nomination of Fellows.

2. The Council appointed an <u>ad hoc</u> committee to consider the nomination of W L Harkness for election as Fellow, and asked that

this Committee report back to the second Council meeting.

3. An <u>ad hoc</u> committee is to report on a recommendation for IMS to participate in the pending ASA Survey of its members.

4. After discussion of the Report of the IMS Publications Committee, the following Council actions were taken:

a) The Council asked the Executive Secretary to charge the 1978-1979 Publications Committee with the task of contacting the ASA Publications Committee with the aim of conducting a joint effort to bring out the Savage Volume and the Hotelling Volume as joint ASA-IMS efforts.

b) The Council approved as IMS policy that it be a condition of publication that authors of submitted papers assign copyright to the IMS.

c) The Council approved in principle establishment of a <u>Lecture Series in Probability and Statistics</u> to be published and sold by IMS. The Executive Secretary was asked to charge the Publications Committee with the task of finding an Editor to conduct this enterprise.

d) The Council approved the recommendation of the Publications Committee that the volume on Time Series be published with the title of Directions in Time Series.

Business Meeting

1. The Treasurer recommended to the Council that the dues and subscription rates be raised in sufficient amounts to avert deficit operations.

Second Council Meeting

 The Council adopted the following changes in the dues structure:

2. The Council accepted the recommendation against participation in the ASA survey of statisticians. An <u>ad hoc</u> committee was asked to consider the desirability and format of a parallel survey of IMS members.

3. The Council adopted a policy that future nominations to Fellow be without the knowledge of individuals named.

4. The Council set the combined number of <u>Annals</u> pages for calendar year 1979 to a maximum of 2400 pages.

5. The Council gave approval to a lecture note/monograph series in statistics and probability and directed the Publication Committee to recommend an Editor for the series to the Council. Each volume proposed by the Editor and Publication Committee will be subject to approval by the Council as more detailed cost analysis becomes available.

6. The Council agreed, in principle, to joint sponsorship of symposium with ONR.

7. The Council established an <u>ad hoc</u> committee to study a proposal that both <u>Annals</u> add applied sections as a means of broadening IMS membership.

August 1979--Washington, DC

First Council Meeting

1. The Committee on Special Invited Papers is to include among its selections at least one person in each of the following areas: (1) probability, (2) theoretical statistics, (3) applied statistics, and (4) interdisciplinary.

2. A motion that the Annual Election be held in the Spring so that newly elected Council members will be identified prior to the Annual Meeting, was adopted. The Executive Secretary is to draft by-law language for presentation to the Council.

3. A motion that the IMS schedule its US meetings only in states which have ratified the ERA; membership ratification of this policy to be sought by mail ballot to be included in the dues notice.

Business Meeting

No action taken.

Second Council Meeting

1. It was moved to extend regular dues to Western Europe, South

Africa, Japan, New Zealand, and Australia. Uniform rates for nonstudents with reduced rates on request for members from developing countries was adopted. The dues structure is as follows:

2. A motion was adopted to approve expenditures of IMS's share (approximately \$2000) for reprinting "Careers in Statistics".

3. A motion was adopted to set the price of "Advances in Time Series" at \$20, reduced to \$15 for members.

4. A motion was adopted to encourage S Gupta to continue efforts to initiate the <u>Monograph--Lecture Note Series</u> and to request that the Publication Committee study the extent to which IMS should underwrite future publications.

5. A motion was adopted to:

a) Allocate 2600 pages to the Annals for 1980;

b) Encourage editors to aim at reducing the backlog;

c) Charge a committee to study alternatives to raise funds needed to further reduce the backlog or increase page allocations.

6. A motion was adopted to permit editors to increase each <u>Annals</u> issue by up to 35 pages for the remainder of 1979.

7. A motion was adopted to permit the Treasurer to seek voluntary contributions.

August 1980--Ann Arbor, MI

First Council Meeting

1. A motion to allocate 1390 pages to <u>The Annals of Statistics</u> and 1010 pages to <u>The Annals of Probability</u> passed.

2. A motion to set dues of Ordinary Members at \$35 for one <u>Annals</u> and \$44 for two <u>Annals</u>, and of Student Members at \$16 for one <u>Annals</u> and \$20 for two <u>Annals</u>, was passed. 3. A motion to set subscription rates at \$50 for <u>The Annals of</u> <u>Statistics</u> and \$44 for <u>The Annals of Probability passed</u>.

4. A motion to set dues for Institutional Members as \$165 passed.

5. A motion that the <u>Annals</u> inventory from Volume 36 be removed to the Business Office, passed.

6. A motion to charge the Publications Committee to study the desirability and feasibility of a separate publication of long papers was passed.

7. A motion to charge the Operations Committee to consider structural constitutional changes including a paid secretary and centralization of noneditorial offices was passed.

8. A motion that Lilly Hathaway be given, on her retirement, a suitable gift of value approximately \$100, and that the President write her a letter, was passed.

9. A motion to charge the new Editor of the <u>Bulletin</u> to study the feasibility of a Letters to the Editor section was passed.

10. A motion that the chairman of the Committee on Special Invited Papers to request travel funds for foreign speakers and for speakers who are not IMS members, was passed.

11. A motion to charge the President to appoint a committee with a \$500 budget to implement the Student Design Competition was passed.

Business Meeting

1. A motion to require abstracts for all invited papers passed.

Second Council Meeting

1. A motion to suspend dues-delinquent members and to authorize the Treasurer to encourage them to return was passed.

2. A motion to continue the present membership of the Statistics in Science Committee with possible expansion by the President after consultation was passed.

3. A motion to increase the size of the Committee on Special Invited Papers by one member to be appointed to a three year term by the President passed.

4. A motion to authorize a committee to institute an International Student Design Competition passed.

5. A motion to remind the Program Secretary of the requirements for abstracts contained in IMS Program Procedures was passed.

6. A motion to encourage the <u>Bulletin</u> Editor to loosen the upper bound on the length of abstracts for invited papers was passed.

7. A motion to adopt a \$6300 savings due to the reduction of the number of issues of each <u>Annals</u> to 4 per year was passed.

8. A motion to authorize a small committee to consult with the Program Secretary and, when appropriate, with the Committee on Statistics in Science, regarding Special Topics Meetings passed.

9. A motion to authorize a committee to study closer links with various statistical societies, particularly the Bernoulli Society, was passed.

10. A motion to authorize a committee to study the feasibility and recommend implementation of an internship program in industry, government, etc, was passed.

August 1981

First Council Meeting

- 1. The Council authorized the Treasurer to transfer back issues of *The Annals of Mathematical Statistics* to a location in or near Hayward, CA.
- 2. The Council approved placing Preliminary Notices of meetings in one *Bulletin* issue earlier than previously, and a three week advance in abstract deadlines.
- 3. The Council approved \$21,000 total salaries for the Managing Editor's Office.
- 4. The Council directed that future nonroutine mail ballots be preceded by an announcement of the issues to Council members so they may present arguments in writing.
- 5. The Council charged the Operations Committee to consider a policy on sales of address labels.
- 6. The Council approved a \$550 prize for the 1982 Statistical Analysis Competition.
- 7. The Council approved a permanent Business Office in or near Hayward, CA, with a two day a week Business Manager to be hired by the Treasurer with approval of the President.
- 8. The Council approved a committee charged with considering the new journal proposed by the Operations Committee.
- 9. The Council approved continuation of IMS distribution, risk, etc. for the *Lecture Notes-Monograph* Series with printing by either Waverly Press or AMS.
- 10. The Council approved publication of Survival Analysis in the Lecture Notes-Monograph Series.
- 11. The Council approved payment of \$12,035 to ASA as the IMS share in the cost of the *Savage* Volume.
- 12. The Council approved the Committee on Scientific Freedom and Human Rights' resolution on Wen-Chen Chen.
- 13. The Council approved a resolution on the ISI meeting in Argentina.

Business Meeting

No actions taken.

Second Council Meeting

1. Since the site of the next biennial congress of the ISI is in Argentina where organizations have documented widespread suppression of human rights including the arrest and unexplained disappearance of many scientists, the following resolution was adopted by the IMS Council:

The IMS Council recommends (1) that human rights and in particular the freedom of scientists be made an important criterion for selection of sites of future congresses of the ISI and (2) that consideration be given to establishment of a permanent ISI committee on human rights and scientific freedom and (3) that the foregoing recommendations be communicated to the next ISI General Assembly in Argentina, and (4) that the ISI continue its strong efforts to obtain information from the government of Argentina regarding the disappearance of the statistician Carlos Noriega.

- 2. The Council directed the Treasurer to prepare an IMS directory as soon as feasible and then at three year intervals.
- 3. The Editor of the IMS *Lecture Notes-Monograph Notes Series* shall have authority to approve the publications (after appropriate refereeing and in consultation with the Publications Committee and the Treasurer) of up to two manuscripts per year not exceeding a total of 500 pages. Further issues in any one year would require individual approval by the Council. The financial transactions related to the publication of each issue shall be within the responsibility of the Treasurer.
- 4. The Council charged the Publication Committee to prepare a policy on royalties for Council consideration.
- 5. The Council approved dedication of the first 1982 issue of The Annals of Statistics to W. G. Cochran.
- 6. The Council authorized up to 2400 pages to the two Annals of with a ceiling of 1300 allocated to The Annals of Statistics.
- 7. The following dues and subscription rates were approved for 1982:

- 8. The Council established a Neyman Lecture to be given every other year, alternating with the Rietz Lecture. The Neyman Lecture ordinarily will emphasize interactions between statistical theory and scientific research. The Council approved creation of an *ad hoc* committee to make every effort, in consultation with the Special Invited Papers Committee, COPSS and ASA to nominate a 1982 Neyman Lecturer.
- 9. The Council voted to encourage interested parties to contact the Program Secretary and Special Topics Committee to explore holding a special topics meeting dedicated to Jack Kiefer.
- 10. The Council charged the Memorial Committee to recommend a suitable memorial to Jacob Wolfowitz.
- 11. The Council approved continuation for 1982 of the ad hoc Special Topics Meetings committee.

August 1982

First Council Meeting

1. The Council agreed with the Treasurer's recommendations that:

- a) The dues and fees structure remain the same as the current fiscal year.
- b) The IMS charge a \$10.00 fee for each manuscript submitted.
- c) The Council investigate the possibility of acquiring a permanent site to house the Business Office.
- 2. The Council authorized S. Gupta, in his capacity as editor of the *Lecture Notes-Monograph Series*, to make available an amount up to \$1,000 to authors of acceptable manuscripts. After a manuscript has been deemed acceptable, the treasurer, in consultation with the editor, should obtain a "best" bid.
- 3. The Council instructed the new publication committee to work toward publication of a Hotelling volume.
- 4. The President appointed a New Publications Committee which will draft a proposal concerning a new review journal to be voted on by mail ballot or to be discussed at next year's annual meeting.
- 5. The Council authorized travel expense payment to A. P. Dawid.
- 6. The Council asked the IMS Scientific Freedom and Human Rights Committee to look into the case of Abram Kagan in the Soviet Union, and to inquire with the director of the Stetlow Institute as to his status and why he cannot emigrate.

Business Meeting

No action taken.

Second Council Meeting

- 1. It was moved that abstracts be required of people who give special invited papers.
- 2. The Council allocated 1,350 pages for *The Annals of Statistics* and 1,100 for *The Annals of Probability*.
- 3. The Council instructed the Executive Secretary to ask the chair of the Special Invited Papers Committee to ask the Wald, Rietz, Neyman Lecturers and the SIP's to submit papers based on their lectures to the appropriate *Annals*.
- 4. The Council voted to make the editor of the *IMS Lecture Notes-Monograph Series* an officer of the Institute to be elected in three year terms.
- 5. The Council approved the appointment of an *ad hoc* committee to investigate what can be done to improve the probability aspect of IMS.
- 6. The Council voted to authorize the Treasurer to hire a 100% Business Manager in the \$25,000 salary range.

August 1983

First Council Meeting

1. The Council voted in favor of a motion to start the publication of a new journal tentatively entitled *The IMS Review*, and to start publication January 1985.

2. The Council approved the motion that an issue of the *Annals* be published in the name of a living person; this matter will be left to the editors of the journals of the IMS.

Business Meeting

No action taken.

Second Council Meeting

- 1. The new dues schedule for 1984 was passed: dues for one Annals would go from \$37 to \$40 (\$6 for the Bulletin and \$34 for the selected Annals), and for two Annals from \$47 to \$52 (\$6 for the Bulletin and \$23 for each Annals). There would be no change in dues for students, retired members, and members residing in developing countries.
- 2. A motion that a new category, Individual Subscribers, be created, was passed. The charge would be \$45 for AOS, \$45 for AOP, and \$11 for the Bulletin.
- 3. A motion that the price for subscribers change from \$55 to \$66 for AOS, from \$48 to \$62 for AOP, and from \$18 to \$20 for the Bulletin, was passed.
- 4. As a result of the report of the Probability Committee, the following motions were passed:
 - a) The IMS shall actively encourage the organization of topically focused meetings. In particular, normally one meeting a year will focus on probability and its applications.
 - b) The President, in consultation with the Program Secretary, shall appoint an Associate Program Secretary for probability and its applications. The term of the office shall be three years. The Associate Program Secretary shall be an ex-officio member of the Special Invited Papers Committee.
 - c) The Council urges the President to reactivate the Membership Committee, directing it to make special efforts to attract probabilists.
 - d) The Council urges the President to establish a Section on Probability.
- 5. The President will appoint an advisory committee to recommend an editorial structure and an editorial board to assist in getting out the first issue of the new journal early in 1985.
- 6. The Council approved 1300 pages for AOS and 1050 pages for AOP, measured in terms of small print size. Since the IMS is switching to the larger print size, the actual number of pages will be somewhat greater.
- 7. A motion that a surcharge of \$5 be paid by those who pay their dues after January 15 was passed.
- 8. The Council approved the proposal to appropriate \$1000 to facilitate a pilot public relations effort to obtain national media attention on statistics and statisticians.
- 9. The Operations Committee was charged to investigate the proposal that the nominating committee nominate foreign members and women, not only West Coast members, etc. Although foreigners are on the ballot, they are generally not elected, possibly because the number of foreign members is small compared to the number of American members.

Executive Meeting

- 1. The Treasurer's suggestion that student member dues be available for seven rather than five years was approved.
- 2. The Committee authorized the Treasurer to let old issues of AMS go out of print.
- 3. It was decided to sell old issues of the *Annals* at cost through advertisements in the *Bulletin* in order to reduce a rather extreme excess inventory.
- 4. The proposal to upgrade the computer was approved.
- 5. A proposed arrangement for the publication of the Neyman-Kiefer proceedings was approved. It will be a joint IMS-Wadsworth venture with IMS members getting a 30% discount. It will not be part of the *IMS Lecture Notes-Monograph Series*.
- 6. The Executive Secretary is to call or send telegrams four weeks before the council meeting to urge attendance or assign proxies.

August 1984

First Council Meeting

- 1. Concerning sponsorship of conferences, the IMS is to share in financial responsibilities and benefits, and the IMS is to have an input into the scientific context of the conference. An *ad hoc* committee will be appointed by the President to arrange details.
- 2. The Council approved of the Treasurer's proposal that distribution of profits from the sale of the *Current Index to Statistics* be shared equally by IMS and ASA.
- 3. The Council voted to donate \$10,000 to the ASA building fund.
- 4. The Council voted to amend the by-laws to make them more flexible regarding collection of dues. This item will go to the membership as a mail ballot.
- 5. On recommendation of the Memorials Committee, the March 1985 issue of the AOS will be dedicated to Julius Blum.
- 6. Reprints will be prepared by the IMS Business Office in Hayward rather than by the printer. This will lead to a considerable saving for IMS.
- 7. The Council approved of the efforts to merge the *Current Index to Statistics* into the Math file.

Business Meeting

- 1. A motion that libraries get second copies of AOS and AOP at half price was presented.
- 2. Several suggestions for the *Bulletin* were made:
 - a) A President's Column,
 - b) A problem section with favorite solutions to standard problems,
 - c) Historical descriptions of statistics departments, and

- d) Letters to the Editor.
- 3. The President announced that Iowa State, IMS, and ASA are entering into an agreement whereby important historical papers will be kept in archives at Iowa State. An Historical Committee will look into such papers.

Second Council Meeting

- 1. The Executive Committee has established an Oversight Committee to set policy for and oversee the activities of the IMS Business Office.
- 2. The IMS journal policy of 50 gratis reprints to authors will be continued for another year. Reprint production will be taken over by the IMS Business Office at a savings of approximately \$8000 in 1985.
- 3. Second copies of the IMS journals ordered at the same address will be available at half price. This move is to encourage libraries to order second copies.
- 4. It was moved and passed that the following policy be adopted on permission to reprinting material from IMS journals:
 - a) original authors may reprint part or all of their articles without charge,
 - b) no charge to noncommercial ventures or memorial volumes,
 - c) requests received from commercial or profit-making ventures will be handled by the Treasurer on a case by case basis.
- 5. A page allocation in 1985 equal to that of 1984 (1,630 journal pages for AOS and 1350 for AOP) was passed.
- 6. A motion was made for a committee to investigate the possibility of typesetting future volumes in the *IMS Lecture Notes-Monograph Series*. The President appointed an *ad hoc* committee to carry out this charge.
- 7. The Committee on Scientific Freedom and Human Rights has been reconstituted and will be asked to investigate the issues raised in two recent letters of concern.
- 8. A motion passed for expanding the committee on Special Papers from six to nine members to ensure broad representation of interests.
- 9. The Council passed a motion that a corporate membership category be established for profit-making institutions; the Oversight Committee will implement this action.
- 10. A new schedule of prices for IMS journals sold to libraries was approved. Specific increases were approved for 1985 and 1986. There will be no changes in dues or subscription prices for individual members in 1985.
- 11. Members should request that their libraries place a standing order for the *IMS Lecture Notes-Monograph Series.* Libraries with standing orders are notified of each new volume in the series and are eligible for 20% prepublication discount.

Executive Meetings

- 1. A proposal to make the *Scandinavian Journal of Statistics* available to IMS member by having it appear on the IMS invoice was approved. The Treasurer is to work a reciprocal agreement similar to the one now in effect with *Biometrika*.
- 2. It was agreed that on the recommendation of the Special Papers Committee, IMS will pay \$200 to Silverman this year, and in future years they are authorized to commit \$500 to speakers' travel expenses.
- 3. In order to avoid repeats, it was decided to make a list of Special Invited paper speakers for the last 6-10 years and to send this list to the Special Invited Paper Committee each year.
- 4. A committee was appointed to investigate the possibility of bringing some aspects of *The IMS Bulletin* production under the Managing Editor and Treasurer.
- 5. The Oversight Committee is to look into winding down the managing editor duties.

August 1985

First Council Meeting

- 1. A motion was made to thank Professor Bruce Trumbo for his careful stewardship and insightful leadership as IMS Treasurer. The motion passed unanimously, and was followed by prolonged applause. Incoming Treasurer Nicholas Jewell was introduced to the Council.
- 2. The Editor of the *Bulletin* noted the initiation of a President's column in 1985 and mentioned the new cover design of the *Bulletin*. He noted that no progress had been made toward the goal of typesetting the *Bulletin*. After some discussion on the most effective scheduling of the *Bulletin* and the possibility of broadening the scope of its coverage, a motion was made that issues related to future changes in the *Bulletin* be referred to the Publications Committee. Specifically, the Committee was charged with studying the content, frequency, cost and method of production of the *Bulletin*, and with reporting their findings and recommendations to the Council. The motion was passed.
- 3. The Editor of the *IMS Lecture Notes-Monograph Series* reported on five forthcoming volumes in the *Series*. The Council urged Editor Gupta to seek to upgrade the quality of camera-ready copy as much as possible. Hopefully, these efforts would be directed at the local level, with appropriate help and advice from *LNMS* editorial assistants.
- 4. A motion was passed that the IMS continue to publish its own directory. It was noted that *The IMS Directory* enhances visibility of IMS, and helps maintain its independence. Sentiment was expressed in favor of participating in the ASA Directory in addition to publishing a separate IMS *Directory*.
- 5. A motion to establish a reserve fund for underwriting previously paid IMS Life Memberships passed.
- 6. A motion passed approving an accelerated schedule for nomination and election of IMS Fellows. The schedule would be intended to facilitate the recognition of new Fellows at the annual IMS meeting.
- 7. The following motion on membership on the SIP Committee passed: (a) the Editors of *The Annals of Statistics, The Annals of Probability,* and *Statistical Science,* and the IMS Program Secretary shall be voting ex-officio members of the SIP Committee, and (b) the IMS Treasurer shall no longer be a member of this committee.

Business Meeting

No action taken.

Second Council Meeting

- 1. A motion to accept the Treasurer's recommendation on 1986 membership dues was passed. Specifically, the dues structure adopted was to offer members three options: members could receive the *Bulletin* and *Statistical Science* for \$30, receive these plus one *Annals* for \$40, or receive these plus both *Annals* for \$50.
- 2. Motions passed for accepting the Treasurer's recommendation on 1986 subscription rates for (non-member) individual subscribers and 1987 rates for libraries. An appropriate resolution satisfying postal regulations also passed. Information on these is available through the IMS Business Office. A motion to offer reduced membership dues of 40% of regular dues to retired and student members and to members in developing countries (as designated by the Council) also passed.
- 3. It was moved that the Business Oversight Committee may approve an adjustment (up or down) in the approved 1987 library rate not to exceed \$5 for a given journal or \$10 for all three journals, upon recommendation of the Treasurer. The motion carried.
- 4. The Council approved a motion authorizing the Treasurer to use an air expediting service to send the *Bulletin* to overseas members, provided the preliminary cost estimate of \$3,000 per year proves valid.
- 5. Approval was given to finalize plans for the 1987 meetings in Blacksburg (E), Dallas (C), and Hawaii (W) as well as Boston for 1988. Some sentiment was expressed in favor of a meeting dedicated to a special topic in Probability. Pyke and Johnson were asked to explore this further. There was some discussion of the desirability of an independent IMS annual meeting. It was noted that current plans involved joint annual meetings with the ASA for five consecutive years (1985–89). Pyke and Johnson were again commissioned to investigate the feasibility of an independent meeting.
- 6. Kempthorne appointed an ad hoc committee in 1984-85 to consider IMS cosponsorship of European meetings. The committee suggested surveying European IMS members on their felt need for formal IMS participation. It was thought that IMS could identify appropriate upcoming meetings of various international societies and make a request to cosponsor by organizing various sessions. Contributed paper sessions might be particularly valuable, since they would provide IMS members at large with a vehicle for participating at meetings. President Meier asked Lucien LeCam to chair on ad hoc committee to study the matter further and make recommendations to the Council. Gupta, Johnson, and van Zwet were also asked to serve; all four agreed.
- 7. The Council approved a motion to publish 1630 journal pages in 1986 in *The Annals of Statistics* and 1350 journal pages in *The Annals of Probability*. The number of journal pages approved was the same as in 1985. The Council approved the publication of 400-500 journal pages in *Statistical Science* in 1986, recognizing the need for some flexibility in this regard in the journal's first year.
- 8. The Council approved the expenditure of \$15,000 in 1985–1986 for publicity and promotion of *Statistical Science*.
- 9. The term of the Executive Editor of *Statistical Science* was approved as three years, beginning in January 1986.

- 10. The Council passed a motion to authorize the President to appoint two additional (*ad hoc*) voting members to the Committee on Selection of Editors for each selection to be made in a given year. The three (core) members appointed to three-year terms would serve on every selection committee. The two additional appointments are meant to ensure that each selection committee has the necessary breadth and expertise for the particular task at hand.
- 11. The Council unanimously passed a motion to amend Article IV, Section 3, of the Constitution as follows (new language italicized):

The Editorial Officers of the Institute shall be the Editors of the official journals of the Institute and the Editors of other publications of the Institute as designated by the Council.

The Council authorized the Executive Secretary to postpone a mail ballot to the membership so that it may be sent with the dues notices in October.

12. The Council noted that former IMS member and Fellow Bruno DeFinetti passed away in July. The matter of formal recognition of deceased members and former members of the Institute was referred to the Memorials Committee.

August 1986

First Council Meeting

- 1. Pursuant to a change in the IMS Constitution approved by members by mail ballot in Fall 1985, a motion was made to (a) confer membership on the IMS Council to the Editor of the *LNMS* and to the Executive Editor of *Statistical Science*, and (b) designate these two Editors as ex-officio members of the IMS Publications Committee. The motion passed.
- 2. A motion to suspend the membership of delinquent IMS members was passed.
- 3. The Program Secretary sought advice on the location of the 1988 Annual Meeting, scheduled for Colorado State University, in view of the fact that the ASA had changed their plans and would be meeting two weeks later in New Orleans. The Council was generally sympathetic with the plan to meet in Fort Collins in 1988. Moreover, there was general concurrence with the sentiment that the IMS should occasionally meet alone or with a society other than the ASA. As a guideline, Meier proposed that the IMS might meet separately from ASA approximately every third year. The Council was in agreement with this statement as a rough guideline.
- 4. Pyke proposed that the IMS cosponsor four upcoming professional meetings: (a) the Pacific Area Statistical Conference in Tokyo in December 1986, (b) the 19th Symposium on the Interface of Statistics and Computer Science in Philadelphia in March 1987, (c) a possible satellite meeting to the ISI Meeting in Tokyo in September 1987, and (d) Environmetrics 1987, a meeting sponsored by the SIAM Institute for Mathematics and Society in Washington DC in November 1987. The Council authorized Pyke to pursue IMS cosponsorship of all four meetings. The details of the cosponsoring arrangement would be developed with each present sponsor. Pyke indicated that a minimal requirement for cosponsorship by IMS would be IMS participation in the planning of the program. Meetings would not be numbered and listed on the inside front cover of *The IMS Bulletin* unless IMS members had the opportunity to contribute papers to the meeting. The Council concurred with the suggestion that IMS cosponsorship of a meeting would be required in order to use the IMS mailing list to inform members about the meeting.

- 5. The Council approved the publication of an IMS *Directory* in 1987, and passed a motion to participate in the COPSS Directory planned for 1988, provided the cost was deemed appropriate. The preliminary estimate obtained for IMS participation was \$6,500.
- 6. Following the recommendation of the Memorials Committee, motions were made to dedicate a forthcoming issue of *The Annals of Statistics* to Harald Cramer, and to organize a memorial session in honor of Cramer at the annual meeting in San Francisco in 1987. The motions passed. With regard to commissioning a memorial article, the need for interaction and cooperation between the Committee on Memorials and IMS Editors was emphasized.
- 7. The recommendation of the Committee on Special Invited Papers on individuals selected for 1986–87 was moved and passed.
- 8. It was noted that three of the Special Invited Papers would be delivered at US meetings by scholars living outside the US. A motion was passed to allocate up to \$500 (if needed) for each of these three speakers in order to facilitate their travel to the meeting at which the paper would be given.
- 9. A motion to provide more lead-time in selecting named lecturers was made as follows: Named lecturers (Wald, Rietz, etc.) shall be nominated by the IMS Council at least 16 months before the meeting involved. The Committee on Special Invited Papers shall meet at the annual meeting in order to consider named lecturers for the meeting two years hence. The motion passed.
- 10. There was a brief discussion on IMS participation in the AAAS. It was noted that the IMS had the opportunity for representation in an additional (fifth) section, and that a number of AAAS sections seemed appropriate for IMS participation. The Council agreed to submit suggestions on future IMS representatives to AAAS to President-Elect Pyke, and to leave the option of adding a representative to a fifth section to Pyke's judgement.
- 11. Styan indicated a few planned changes for *The IMS Bulletin*. He indicated his intention to concern himself with the readability and proper referencing in abstracts, but to eschew taking responsibility for the abstracts' contents. A motion passed to the effect that an abstract would be rejected only if such was supported by a unanimous vote of IMS officers responding to a mail ballot on the question of rejection.
- 12. President Meier presented his report (published separately in *The IMS Bulletin*). He moved that an *ad hoc* committee be formed to study and make recommendations regarding the administrative structure of IMS. The motion passed.
- 13. It was moved that the IMS take an active part in advancing the role that statistics as a discipline will play on the national science scene. The motion passed. J. Sacks was asked by President Meier to represent the interests of the IMS in meetings scheduled with the ASA on this topic.
- 14. It was moved that the IMS transmit to Edward Wegman a note of thanks for his leadership and support of the statistics research community during his tenure at the Office of Naval Research. The motion passed.

Business Meeting

No actions taken.

Second Council Meeting

- 1. Program Secretary Billard moved that the Council approve a number of future meeting sites:
 - a) Motion to hold the Central Regional Meeting of the IMS in Madison, Wisconsin, May 14-16, 1988, joint with SIAM, was approved.
 - b) Motion to hold the Annual Meeting of the IMS at Colorado State University in Fort Collins, Colorado, August 8-11, 1988, was approved.
 - c) It was moved that the Western Regional Meeting be held at Montana State University in Bozeman in June, 1988. Considerable discussion ensued. Concern was expressed that this location was not a good choice during the same summer in which the Annual Meeting was to be held in Colorado. It was thought that few IMS members would choose to travel to both meetings. The motion to hold a meeting in Bozeman in 1988 did not pass.
 - d) Motion to hold the Western Regional Meeting of the IMS at the University of California, Davis, in June 1989, during the tenth anniversary of the Division of Statistics there was approved.
 - e) There was a lengthy discussion concerning the upcoming meeting in Honolulu. Plans were underway to hold the Western Regional Meeting of the IMS in Honolulu in June 1987. Several Council members mentioned conflicting meetings, although it was acknowledged that some conflicts were unavoidable. Concern was expressed about the fact that no local arrangements chairman had been identified, and that the hotel where the meeting would be held would not handle fees not directly related to housing. It was moved that the Honolulu meeting in 1987 be cancelled, and that the Western Regional Meeting of the IMS in June 1988 be scheduled for Honolulu. The motion passed.
- 2. The Council approved the following resolution on dues in 1987 put forward by the Treasurer:

Resolution: The scientific journals of the Institute of Mathematical Statistics are Statistical Science, The Annals of Statistics, and The Annals of Probability. The IMS Bulletin is the news organ of the Institute. Each individual member receives The IMS Bulletin and Statistical Science. Members receiving only these two journals pay annual dues of \$30 and \$10 is added to the dues for each Annals selected. Of the total dues paid, \$8 is allocated to The IMS Bulletin and the remaining amount is allocated equally among the scientific journals received.

- 3. The Treasurer moved that general subscription prices in 1988 (i.e., prices to libraries) be set at \$45 for *Statistical Science*, \$95 for *Statistical Science* plus one *Annals* and \$165 for *Statistical Science* plus both *Annals*. This represents a modest increase over approved 1987 prices. The motion passed.
- 4. Jewell asked the 1987 Council for advice regarding the information to be collected from members and on what should actually appear in the *Directory*. The questionnaire prepared by Jewell was approved in principle. The Council passed a motion that the following information be published: Name, Title, Address(es), Direct Phone and Message Phone numbers, Computer Address, Education, Institutional Affiliation.
- 5. The Council endorsed the idea of IMS participation in the planned joint *Directory of Statistical* Societies, subject to satisfaction of the Executive Committee on the cost suggested by ASA.
- 6. The proposed charter of the Committee of Presidents of Statistical Societies (COPSS) was distributed and discussed. A motion was made to approve the charter (as revised in July 1986). The motion passed.

- 7. The Treasurer moved that \$10,000 be allocated in 1986-87 for continued promotion of *Statistical Science*. The promotion campaign would be directed primarily at libraries. The motion passed.
- 8. A motion to allocate 1630 printed pages to *The Annals of Statistics* in 1987 passed. A motion to allocate 1600 printed pages to *The Annals of Probability* in 1987 passed. A motion to allocate up to 600 pages to *Statistical Science* passed. Details on the budgetary needs of *The IMS Bulletin* in 1987 could not be accurately estimated at the time of the meeting. Costs will be generated by the move of the editorial office to Canada, by the purchase of needed equipment, and by changes in the form and style of the *Bulletin*. The Treasurer, as a tentative allocation, has earmarked the *Bulletin* budget for a 25% increase. More details will be made available to the Council in due course.
- 9. Paul Meier indicated that he was uneasy with a motion passed in the first Council meeting regarding setting policy on the rejection of abstracts submitted to *The IMS Bulletin*. He indicated that his earlier motion treated the *Bulletin* Editor differently from other Editors. He moved that the following resolution be passed by the Council:

Resolution on Editing of the IMS Bulletin and Publication of Abstracts

The 1987 Council, mindful of the concern that *The IMS Bulletin* conform to the highest standards and, at the same time, mindful also of members' individual interests in control over the content of their own abstracts, resolves as follows:

- (a) The Editor of *The IMS Bulletin* has the usual prerogatives of a journal editor. Except for limited purposes, described below, the Editor is the final judge of the suitability of material for publication in the *Bulletin*.
- (b) With respect to research abstracts the Editor will be guided by the following considerations.
 - a) To the extent possible, consistent with suitability legibility, and coherence, the author will have maximum latitude in controlling the text. The Editor does not take responsibility for verification of the correctness of assertions in an abstract. He may suggest editorial changes but would ordinarily accept an author's preference.
 - b) Ordinarily an author is entitled to expect the publication of at least one but no more than three abstracts in a single number of the *Bulletin*. The Editor may relax this requirement at his preference.
 - c) The Editor may publish and enforce a standard for the format of abstracts and may supply photographic reproductions of abstracts if he wishes. In that case, the Editor may at his discretion, have an acceptable abstract retyped.
 - d) The Editor may reject an abstract on account of unsuitability (e.g., irrelevance to probability or statistics, documentable error, political content, or failure to be legible and/or coherent), but in such case the author will be advised of his right to appeal to the President of the IMS. In the event of such appeal, the President will consult the Council by mail ballot and, if the majority of the Council vote acceptance, the President shall advise the Editor to publish the abstract in question. (Neither the President nor the Council shall usurp editorial prerogatives. Their advice is to concern the abstract as finally submitted.)
- (c) All previous resolutions of earlier IMS Councils concerning policies regarding the publication of research abstracts are hereby rescinded.

The motion passed.

10. Paul Meier discussed the section of his President's Report (published separately in the *Bulletin*) on the administrative structure of the IMS. It was suggested that Ron Pyke form a committee to study this matter and make recommendations to the Council. Pyke indicated that he would do so.

August 1987

First Council Meeting

- 1. The Treasurer's recommendations on dues and subscriptions prices were approved, and the resolution on allocation of publication budgets to the various IMS journals was passed.
- 2. Motions were passed approving the satellite meeting on probability and its applications in Fort Collins in August 1988, and the Eastern Regional Meeting at Lexington, Kentucky, in 1989.
- 3. The Council approved the publication of 1750 pages for *The Annals of Statistics* and 1600 pages for *The Annals of Probability* in 1988. An allocation (in Canadian dollars) of C\$21,500 for the *Bulletin* Editorial Office and C\$5,000 for continued development of a desktop publishing system was approved for 1987. For 1988, the figures approved in each of these categories were C\$20,760 and C\$2,000, respectively.
- 4. The recommendations of the Committee on Special Invited Papers on the speakers to be invited to deliver papers in 1988 was approved. A motion to allocate US\$500 to each of three speakers who must travel from abroad to deliver their addresses was approved.

Business Meeting

No actions taken.

Second Council Meeting

- 1. The Treasurer introduced a motion to expel delinquent members. The motion passed.
- 2. The Council approved the following motions:
 - a) Financial Reorganization
 - i. The page budget for *The Annals of Probability* is set at 1500 printed pages for FY88. An additional 300 printed pages is approved for FY88 and recommended for FY89 to reduce the backlog.
 - ii. The President, President-Elect, Past President, Treasurer, and Executive Secretary shall constitute the President's Committee and, following the general policies established by the Council, shall serve as an advisory body for the President. The committee will receive copies of all Presidential correspondence and ordinarily will meet twice between annual meetings of the Council.
 - iii. The Committee on Investments and Finance is abolished and the Business Oversight Committee's charter will be allowed to lapse. The functions of these committees will become the responsibility of the President's Committee.
 - iv. The Treasurer and Business Manager will prepare quarterly financial reports for the President's Committee, to assist it in its financial oversight responsibilities.
 - v. The Committee on Operations, in consultation with the President's Committee, will prepare revisions as appropriate to the Constitution and By-Laws and as necessitated by the above actions and other actions.

b) Applied Probability

- i. The President will appoint a Steering Committee on Applied Probability for a three-year term to be responsible for fostering and guiding IMS activities involving the applications of probability. The committee will consist of six members with stature and expertise in significant areas of applied probability, including publications and programmatic experience.
- ii. The Council encourages the submission of items on Applied Probability for possible publication in the *Bulletin*. The Steering Committee will be responsible for soliciting such submissions.
- iii. The Steering Committee, in consultation with the Publications Committee (augmented by *ad hoc* appointments by the President), will study the desirability and feasibility of a new journal devoted to topics in Applied Probability and will report its recommendations to the President before the 1988 IMS Council meeting in August 1989.
- c) Long Range Program Plans

The President will appoint an *ad hoc* Program Planning Committee to consider long-range goals and to make recommendations on timely topics and structural innovations for future IMS meetings. The chair of the Special Invited Papers Committee, the Program Secretary, and the Associate Program Secretary for Probability and its Applications will be ex-officio members of the committee. The committee shall be sufficiently large to ensure the necessary breadth of ideas and backgrounds.

- d) Future meetings
 - i. The 2nd World Congress of the Bernoulli Society will be held in Uppsala, Sweden, in August 1990. The Council approved a motion by L. Billard that the IMS cosponsor this meeting with the Bernoulli Society and that the 1990 Annual Meeting of the IMS be held in conjunction with the Congress.
 - ii. The IMS will cosponsor the 1988 Interface Symposium in Reston, Virginia (near Washington, DC), 21–23 April 1988.
 - iii. The Eastern Regional Meeting will be held in conjunction with ENAR in Baltimore, Maryland, 1-3 April 1990.
 - iv. The Western Regional Meeting will be held in conjunction with the Biometric Society (WNAR) in Bozeman, Montana, June 1990.

August 1988

First Council Meeting, August 14, 1988

- 1. Members delinquent in paying their dues as of August 1988 were expelled.
- 2. Carl Morris was appointed incoming Executive Editor of Statistical Science, and Jessica M. Utts was appointed incoming Treasurer.
- 3. The 1986–1987 Council decision to unbundle Statistical Science was delayed for one year.
- 4. General Subscription prices for 1989 were set as follows:

 - c) A Special Topics meeting in East Lansing, Michigan in May 1990
- 6. The following page requests for 1989 were approved:

1750 pages for the Annals of Statistics

 $1500~\mathrm{pages}$ for Annals of Probability, plus $150~\mathrm{pages}$ for a special issue dedicated to A. N. Kolmogorov

- 7. The Memorial Committee's recommendation that an issue of each *Annals* in 1989 be dedicated to A. N. Kolmogorov was approved, with implementation details left to the judgment of the two editors.
- 8. The Managing Editor's position was divided into two equal parts:
 - i. A Managing Editor for the two Annals,
 - ii. A Managing Editor for Statistical Science and the other IMS publications

Business Meeting, August 15, 1988

No actions taken.

Second Council Meeting, August 16, 1988

- 1. President Gnanadesikan appointed two new ad hoc committees: the Young Researchers Committee and the Outreach Committee. The Young Researchers Committee will consist of statisticians within six years of their PhDs and consider the needs of new researchers and ways to increase their participation in IMS. The Outreach Committee will be broad-based and consider such issues as a membership survey and future program planning.
- 2. The following motion concerning the *LN-MS* editor was accepted:

The Editor of the *Lecture Notes-Monograph Series* will also edit individual volumes published by the IMS. The Editor will appoint an Editorial Board empowered to approve publication of individual volumes. Financial aspects of individual-volume publication will be coordinated with the Treasurer.

3. A new Annals of Applied Probability was approved with the following resolution.

The IMS will publish in the area of Applied Probability, with a first-issue target date of January 1991. The President shall appoint a Committee to guide the formation of the new journal. The Committee will include the Chairman of the Publications Committee, the IMS Treasurer, representatives of the editorial boards of *The Annals of Statistics, The Annals of Probability, Statistical Science*, and other members as appointed by the President. The Committee for the Selection of Editors is charged with recommending an editor for the proposed journal no later than January 1989.

In implementing the above resolution and establishing the editorial guidelines and intended coverage for the proposed journal, there should be careful coordination with the Editorial Boards of *The Annals of Probability* and *The Annals of Statistics* to assure that the traditional domain and coverage of *The Annals of Probability* and *The Annals of Statistics* not be diluted.

- 4. The following future meetings were approved:
 - a) A joint meeting with the Biometric Society/ENAR March/April 1991
 - b) A joint meeting with the Biometric Society/WNAR June 1991
 - c) The 1991 Annual meeting to be held jointly with ASA/ENAR/WNAR in Atlanta, GA August 1991

Numbered meetings must satisfy the same requirements and, in addition: the Program Chair (if one person) or IMS Program Chair (joint meeting) must be appointed or approved by IMS Program Secretary in consultation with the IMS President, IMS must be represented on the Program and Local Arrangements Committees, and IMS may participate financially, with the decision to be made on a case-by-case basis. Variations in specific cases should be approved by the IMS Executive Committee. Council must approve both Numbered and Co-sponsored meetings. IMS offers the following services for co-sponsored meetings: general information, call for papers, brief program (e.g., invited papers) published in the *IMS Bulletin*, and access to IMS membership for collaboration in program development. In addition, for numbered meetings: full information (including registration forms), program, abstracts of IMS invited and contributed papers published in the *IMS Bulletin*, use of IMS mailing list, IMS financial participation and share in the profit or loss, access to special invited lecturers, and higher level of IMS participation in program development.
- 4. Council passed a motion advising the Program Secretary to seriously consider holding the IMS 1997 annual meeting separate from all other societies.

5. Beginning in January 1995, subject to the concurrence of newly selected editors, *The Annals of Statistics* will conduct a pilot study on double-blind refereeing. Members pay the annual dues of \$60. An additional amount is added to the dues of members depending on the scientific journal selected as follows: Statistical Science (\$10), The Annals of Applied Probability (\$15), The Annals of Statistics (\$25) or The Annals of Probability (\$20). Of the total dues paid, \$29 is allocated to The Bulletin and the remaining amount is allocated equally among the scientific journals received.

July 1995

First Council Meeting, July 10, 1995

The following motions were approved.

- 1. Members who were delinquent in paying their dues were suspended.
- 2. The Council approved a numbered meeting to be held jointly with ENAR in March or April of 1997 and a numbered meeting to be held jointly with WNAR in June, 1997.
- 3. Sue Wilson was voted in for a second term as the Editor of The IMS Bulletin.
- 4. The Council approved the following two motions:
 - (a) The IMS Annual Address. At each Annual IMS Meeting there will be an IMS Annual Address. The Address will be open to the public and will usually be presented in the evening, one or two days following the first meeting of the IMS Council. The Address will be presented by the outgoing IMS President, or by an individual selected by the President, and will be a statement to the membership on the topic of mathematical statistics, broadly interpreted. The Address will be published in the Statistical Science. The Address will be preceded by the presentation of the new IMS Fellows, and any other announcements or awards deemed appropriate for the occasion.
 - (b) The JSM Joint Policy Committee. The IMS will enter into negotiations with the JSM partner societies to form a Joint Policy Committee charged with the oversight of the JSM. It is anticipated that this Policy Committee will (i) consist of one member designated from each society; (ii) will be charged with the approval of the location and financial arrangements of future JSM's; (iii) will be responsible for financial review and oversight of past JSM's; (iv) will be responsible for recommending changes in the structure of the JSM agreement when necessary. The development and planning of JSM will remain with the ASA Committee will cooperate with ASA to ensure that meetings through 1999 will proceed smoothly. In particular, the IMS will accept the financial arrangements for 1996.

Organizational membership dues will remain the same at \$450 for Institutional Membership and \$750 for Corporate Membership.

- 3. Resolved: The scientific journals of the Institute of Mathematical Statistics are Statistical Science, The Annals of Statistics, The Annals of Probability, and The Annals of Applied Probability. The IMS Bulletin is the news organ of the Institute. Each individual member receives The IMS Bulletin and must elect to receive at least one of the four scientific journals. Members pay annual dues of \$60. An additional amount is added to the dues of members depending on the scientific journal selected as follows: Statistical Science (\$15), The Annals of Applied Probability (\$20), The Annals of Statistics (\$30) or The Annals of Probability (\$25). Of the total dues paid, \$29 is allocated to The IMS Bulletin and the remaining amount is allocated equally among the scientific journals received.
- 4. IMS cosponsorship of the 1997 International Symposium on Contemporary Multivariate Analysis and Its Applications to be held in Hong Kong, May 19-24, 1997, was approved by the Council.
- 5. The sense of the following six motions was passed by the Council.
 - (a) Electronic Diffusion of Information. The IMS Council recognizes both the widely distributed nature of its organization and membership, and the convenience and power of electronic information exchange. It shall be IMS policy that paid IMS staff, including the staff in the Business Office, production editors, and editorial assistants, have the ability to exchange standard computerized information both routinely and easily. By "standardized computerized information" it is meant that there will be certain recognized file types, such as Microsoft Word, Microsoft

Excel, LaTeX, Postscript, Compressed Postscript, and Plain ASCII text, that IMS staff will be familiar with as standard items. By "routine and easy" exchange it is meant that the staff will develop familiarity and proficiency in using standard means of Internet information access and transfer, including transfer by e-mail, e-mail with attachments, anonymous ftp, and World Wide Web. It is also meant that the staff will develop familiarity with standard tools for information archiving and compression that are used as part of such information exchange. The IMS Executive Committee is charged with developing training and evaluation programs that will implement the spirit of this resolution. The President shall report to the Council at the 1996 Annual Meeting on the achievement of these goals.

- (b) Integration of E-mail into IMS Practice. The Council recognizes the ubiquity of e-mail usage among IMS members, and wishes to integrate e-mail communication into the organizational practice. The Executive Committee will take steps to ensure (i) compilation of an up-to-date database for member information, including address, e-mail, fax no., etc.; (ii) development of a scheme to maintain the database directory; (iii) making the directory available on-line to members desiring to find database of addresses of other members; and (iv) development of the ability of the Business Office staff to use the database addresses to contact large subsets of the IMS membership where this can save money or time in the future. The President shall report to the Council at the 1996 Annual Meeting on progress in meeting these goals.
- (c) Development of a Pilot IMS World Wide Web Site. The Council recognizes the importance of WWW as a tool for disseminating information to members, in particular about IMS activities and products. The Council also recognizes that WWW is an important means for advertising IMS to the world at large and for attracting new members. The Council also recognizes that much of the work going into The IMS Bulletin can be used without much extra effort to good effect on WWW. The Council directs the President to appoint a committee of IMS members, that will include the Editor of The IMS Bulletin, which will organize a a pilot WWW site. This WWW site will offer, at the least, basic information about how to join IMS, about meetings of the IMS and related societies, and about advertised job opportunities. This committee will seek ways in which the WWW site can painlessly profit from efforts in compiling The IMS Bulletin. This committee will also seek to develop e-mail address servers, abstract servers, and explore the possibility of offering advertising relationships with commercial publishers. The committee will seek comments on the WWW site, in particular as regards issues like privacy and convenience, and will prepare a report on the site. The committee will report to the Council during the 1996 Annual Meeting on the structure and effort involved in setting up and maintaining the site, on likely directions for future efforts, and on member and public reactions to the site.
- (d) Search for Web Editor. The Council recognizes that the job of of developing and maintaining a formal IMS WWW site would be a significant one and would require both leadership and sustained effort. The Council directs the President and the Executive Committee to search for a Web Editor with term projected to begin following the 1996 Annual Meeting. At this meeting the President and the Executive Committee will report on the prospective Editor, on the services that are envisioned to be offered routinely at a prospective WWW site, and on the costs to IMS that such services would entail. The Council at that time will deliberate on the formal establishment of a WWW site and prospective choice of an editor.
- (e) Electronic Journals. The Council recognizes the interest of members and of other learned societies in the possibility of electronic journals. It has been said that electronic technology will inevitably change the business of scholarly publishing. The Council intends to evaluate such claims soberly and thoroughly. The Council directs the President to form a committee to enquire (i) about the possible advantages and disadvantages of electronic journals; (ii) about the

existing technology for serving electronic documents, for obtaining payment, and for protecting interest in intellectual property; (iii) about what other learned societies and commercial publishers are doing; (iv) about what, if any, electronic service/products the IMS might offer, and about potential costs and benefits of such actions. The committee shall include representatives from the Editorial boards of IMS journals and other IMS members.

(f) The IMS will consider affiliation with the new journals, Electronic Journal of Probability and Electronic Communications in Probability. The Publications Committee, in consultation with the ad hoc Committee on Computerization, will negotiate with the new journals on the nature of this affiliation.

August 1996

First Council Meeting, August 5, 1996

The following motions were approved.

- 1. Due to a balanced budget, all subscription rates will remain unchanged.
- 2. Delinquent members will be suspended after a second renewal notice is sent, along with a letter from the President.
- 3. The following meetings were approved:
 - (a) IMS cosponsorship of an unnumbered Meeting, the Seminar on Stochastic Processes, to be held at Princeton University, March 20-22, 1997.
 - (b) a numbered IMS Meeting, IMS/SPES Spring Research Conference, to be held at Rutgers University, sometime in May-June, 1997.
 - (c) IMS cosponsorship of an unnumbered Meeting, the Nineteenth Midwest Probability Colloquium, to be held at Northwestern University, October 17-18, 1997.
 - (d) a numbered IMS Meeting, the Meeting of New Researchers, to be held at University of Wyoming, July 23-26, 1997.
 - (e) a numbered IMS Meeting, the Eastern Regional Meeting, to be held in Pittsburgh, March, 1998.
 - (f) a numbered IMS Meeting, the Western Regional Meeting, to be held in June, 1998.
 - (g) the numbered IMS Annual Meeting, held jointly with the Joint Statistical Meetings, to be held in Atlanta in 2001.
- 4. Publication of an Index of the first six years of *The Annals of Applied Probability* and a page increase to 1400 page; a page increase to 2200 pages for *The Annals of Probability*.
- 5. The appointment of Richard T. Durrett as the new Editor of The Annals of Applied Probability.
- 6. Two sessions IMS Special Topics Meeting to be held in Chapel Hill in October, 1997, to be dedicated to the memory of Stamatis Cambanis.
- 7. Restructuring the New Researchers Committee and that Article V (f) of the By-Laws be changed to read: 'New Researchers Committee. The Committee's responsibility is to assist the IMS in understanding and meeting the needs of new researchers, especially concerning publications and meetings. The Committee will also be in charge of organizing and running the New Researchers Conference, under the supervision of the IMS Program Secretary. The members of the Committee

will serve 3 years. One of those members shall be designated as chair by the IMS President, in consultation with the New Researchers Committee and the IMS Program Secretary. If needed, a Local Arrangements Chair for the New Researchers Conference will also be selected by the same process.'

- 8. Abolition of the Travel Awards to New Researchers Committee and reserving the existing funds for support of the New Researchers Conference.
- 9. Subcommittee on Electronic Publishing's proposal which includes the following motions:
 - (a) The IMS is to provide support to set up WWW homepages for each of the Annals and for Statistical Science, edited by the appropriate journal editors and accessed from the overall IMS page.
 - (b) The IMS is to provide the author(s) of each accepted paper with a limited waiver of copyright allowing electronic copies of such papers to be disseminated by the authors.
 - (c) The editor of each journal should indicate, on their WWW site, the location at which such preprints can be accessed, and shall indicate the status (accepted, published, etc.) of each such paper.
 - (d) The IMS shall finalize development of style files for authors submitting to journals, and shall locate these at each WWW site and actively encourage authors to use such styles for disseminating accepted papers.
- 10. Regarding IMS affiliation with The Electronic Journal of Probability (EJP) and The Electronic Communications in Probability (ECP)
 - (a) EJP/ECP can advertise that they are journals affiliated with the IMS, and the IMS will list the contents of these journals in the Bulletin.
 - (b) The IMS will oversee the appointment of future editors of the journals, after the current editors finish their three year terms. This, and other matters involving EJP/ECP will be decided in consultation with the EJP/ECP advisory board. Future advisory boards will also be chosen by the IMS.
 - (c) No financial support for the journals is to be provided at this time, although requests for support might be considered in the future.
 - (d) The IMS may end this affiliation at its discretion. After some discussion the Council approved the IMS affiliation as described.

Business Meeting: August 6, 1996

No actions taken.

Second Council Meeting, August 8, 1996

The following motions were approved.

- 1. All subscription rates will remain at the present level.
- 2. The following U.S. Postal Service Regulation:

Resolved: The scientific journals of the Institute of Mathematical Statistics are Statistical Science, The Annals of Statistics, The Annals of Probability, and The Annals of Applied Probability. The IMS Bulletin is the news organ of the Institute. Each individual member receives The IMS Bulletin and must elect to receive at least one of the four scientific journals. Members pay annual dues of \$60. An additional amount is added to the dues of the members depending on the scientific journal selected as follows: Statistical Science (\$15), The Annals of Applied Probability (\$20), The Annals of Statistics (\$30) or The Annals of Probability (\$25). Of the total dues paid, \$29 is allocated to The IMS Bulletin and the remaining amount is allocated equally among the scientific journals received.

- 3. The Business Office and the IMS Web Editor will prepare the membership list for inclusion in the IMS Web Page, and will then seek approval of Members for inclusion.
- 4. Establishment of an Ad Hoc Committee on Technology Policy of undetermined size, to be appointed by the 3 Presidents whose responsibility will be assisting the President and the Council on various matters of electronic dissemination of information, privacy rights of Members, legal aspects involved, etc.
- 5. The Nominating Committee, which is announced during the Business Meeting, be approved by the Council in the First Council Meeting that takes place before the Business Meeting.
- 6. Giving \$5000 to the New Researchers Committee for their meeting in Laramie, Wyoming in 1997.
- 7. The Officers Meeting and the First Council Meeting will be merged to avoid an extra day that was necessitated this time by the (inaugural) IMS Presidential Address.

July 1997

First Council Meeting, July 27, 1997

Council approved two more numbered IMS Meetings for 1999:

- (a) the Spring Eastern Regional Meeting, joint with ENAR, in Atlanta.
- (b) the Western Regional Meeting, joint with WNAR in Albuquerque.

The following motions were approved:

- 1. The appointment of Leon Gleser to be the new editor of *Statistical Science*; other editorial appointments were approved earlier by email ballots.
- 2. The following revised guidelines for the Fellows Committee. Changes included an updating of the scholarly qualifications to read:
 - (a) The candidate shall have demonstrated distinction in research in statistics or probability, by publication of independent work of merit.
 - (b) The first qualification may be partly or wholly waived in the case of (1) a candidate of wellestablished leadership, whose contributions to the field of statistics or probability other than original research shall be judged of equal value; or (2) a candidate of well-established leadership in the application of statistics or probability, whose work has contributed greatly to the utility of and application of these areas.

- (c) The qualifications require membership in IMS: Perspective Fellows should have been members on December 1 of the year preceding the one in which they are to be considered for Fellowship by the committee. Candidates should also have shown a commitment to the IMS by having been members of the society for at least two years.
- 3. Approval of this year's nominating committee, followed by a discussion of the tradition of nominating only one candidate for IMS President. Although Council's vote was unanimous in its approval of this tradition, they wished to facilitate the right of members to nominate additional candidates as stated in the bylaws. To help facilitate this privilege, the President will advise the nominating committee to publish their candidate at least 5 months prior to the election. To encourage some continuity in the nomination process it is advised that each year's chair be an *ex-officio* member of the next year's nominating committee.
- 4. A session at an upcoming meeting will be in honor of the late Raj Bahadur.
- 5. In the future any electronic membership list will be inclusive unless a member specifically requests to be excluded. With the new membership database it would be desirable to have a printed directory. The COPSS directory will not be updated because ASA is not interested. The IMS will publish a directory and this directory may include other societies as well. The Bernoulli Society has requested that the IMS publish a joint directory.
- 6. Workshop speakers may be paid a reasonable amount for their travel expenses, provided that the budget is revenue neutral with no honorariums. The budget needs to be approved by the Program Secretary and the Treasurer. This motion was narrowly approved and so will be followed with great caution.
- 7. Council voted to make the ad-hoc committee on electronic issues a standing committee. The duties of this committee are to be determined by following the recommendations made by David Donoho. These duties include looking into issues surrounding electronic publishing and electronic issues per-taining to the IMS Business Office. As there is some overlap between this committee and the publishing committee, the committees should have a cross-appointment.

Business Meeting: July 29, 1997

Second Council Meeting, July 30, 1997

1. The following U.S. Postal Service Regulation was approved:

Resolved: The scientific journals of the Institute of Mathematical Statistics are Statistical Science, The Annals of Statistics, The Annals of Probability, and The Annals of Applied Probability. The IMS Bulletin is the news organ of the Institute. Each individual member receives The IMS Bulletin and must elect to receive at least one of the four scientific journals. Members pay annual dues of \$60. An additional amount is added to the dues of the members depending on the scientific journal selected as follows: Statistical Science (\$15), The Annals of Applied Probability (\$20), The Annals of Statistics (\$30) or The Annals of Probability (\$25). Of the total dues paid, \$29 is allocated to The IMS Bulletin and the remaining amount is allocated equally among the scientific journals received.

- 2. JSTOR, a nonprofit organization, has approached IMS with an offer to make IMS journals available in libraries. A motion was passed that the IMS negotiate a contract to put the *Annals of Mathematical Statistics* up immediately and then revisit the issue.
- 3. The Council adopted the sketch of a family of gamma curves, designed by B. Ferguson, for the IMS official logo.

August 1998

First Council Meeting, August 9, 1998

- 1. Council approved the following resolution. In order to control costs of Lecture Notes-Monograph Series volumes, particularly conference proceedings, the IMS will take the following actions:
 - (a) Complimentary copies of LNMS volumes of conference proceedings will be limited to one per author and editor with a maximum of 50 free copies.
 - (b) The IMS will no longer pay the cost of typing conference proceedings and will only accept text in camera ready form.
 - (c) The IMS will make efforts to aggressively advertise to libraries and book vendors. IMS will communicate to libraries the value of having conference proceedings available, especially for graduate students working in the field.
- 2. Council approved the following meetings:
 - (a) the 1999 IMS Eastern Regional Meeting, joint with ENAR, in Atlanta, Georgia.
 - (b) the 1999 IMS Western Regional Meeting, joint with WNAR, in Seattle, Washington.
 - (c) the 1999 New Researchers' Workshop, at Johns Hopkins University.
 - (d) the 1999 Spring Research Conference in Industry.
 - (e) the Spring Research Conference on Statistics in Industry, joint with ASA section on Physical and Engineering Science, in Minneapolis-St. Paul.
 - (f) Council also approved a motion to arrange the Annual Meetings in Banff, British Columbia, in the year 2002.
- 3. Council decided that in the future, the chair of each of the Standing Committees would create a short document describing the nature of their duties which can be passed on to the next committee chair. These files will be housed at the IMS Business Office. It was also decided that each committee chair be given a copy of the IMS handbook and that the handbook would be made available on the IMS website.
- 4. The editors of Annals of Applied Probability, Annals of Probability, Annals of Statistics, Statistical Science and the IMS Bulletin requested no additional page allocations and Council approved the requested page limits.
- 5. Council voted to support a fact finding venture to consider the possibility of the joint publication of The Lecture Note Monograph Series (LNMS) with Cambridge University Press. The committee will consist of Miki Donoho, Joe Eaton, Julia Norton and Elyse Gustafson.

6. Council passed a motion to form an advisory board known as the Committee on Long Term Goals and Institutional Memory. Past President Nancy Reid will be asked to implement a plan for this.

Business Meeting: August 11, 1998

No actions taken.

Second Council Meeting, August 12, 1998

1. The following U.S. Postal Service Regulation was approved:

Resolved: The scientific journals of the Institute of Mathematical Statistics are Statistical Science, The Annals of Statistics, The Annals of Probability, and The Annals of Applied Probability. The IMS Bulletin is the news organ of the Institute. Each individual member receives The IMS Bulletin and must elect to receive at least one of the four scientific journals. Members pay annual dues of \$60. An additional amount is added to the dues of the members depending on the scientific journal selected as follows: Statistical Science (\$15), The Annals of Applied Probability (\$20), The Annals of Statistics (\$30) or The Annals of Probability (\$25). Of the total dues paid, \$29 is allocated to The IMS Bulletin and the remaining amount is allocated equally among the scientific journals received.

- 2. Council approved a motion that the IMS cosponsor the Western Regional meeting, jointly with WNAR and SSC in Vancouver in 2001, but the profits from this meeting will be devoted to the New Researchers Conference or to students attending IMS conferences. The Western Regional meeting with be canceled for the year 2000.
- 3. It was decided via informal vote that at the JSM, the time slot for the IMS that was approved by the ASA board (each of the 5 participating societies will have one session) will be utilized as a single speaker slot.
- 4. A committee will be formed to explore a joint venture with ISI regarding the Statistical Theory and Methods abstracts and the CIS.

Electronic Council Meeting, November 3, 1998

- 1. Via an email vote, Council passed the motion that Statistical Science subscriptions will be made available to ASA members at a reduced price, beginning in 1999, at the initial price of \$49. The ASA will include this as part of their annual membership renewal materials.
- 2. Via an email vote, Council passed the following motion regarding the the Electronic Journal of Probability (EJP):
 - (a) We will establish a formal Board arrangement with IMS appointing 3 advisers to rotating 3-yr terms.
 - (b) As with other IMS joint ventures (e.g. Current Index and JCGS) the Board will carry out editorial searches and recommend to Council the nominee to be the new editor of EJP.

Electronic Council Meeting, December 6, 1998

1. Via an email vote, Council approved the following motion:

Beginning in the dues year 2000, IMS will identify the countries in which members receive reduced dues using the latest World Bank figures available for the GNP per capita. The countries in which members receive reduced dues rates will be those with a GNP per capita of \$5000 or less. The World Bank identifies these countries as "lower and lower middle income countries."

The list of reduced dues countries will be published in the May/June issue of the Bulletin prior to the October mailing of the dues invoices for the upcoming year. The figures used will be those available on May 1 of that year.

Electronic Council Voting Results, February 1, 1999

Via an email vote, Council approved the appointment of Barry C. Arnold as Managing Editor for Statistics.

Electronic Council Meeting, February 27, 1999

Via an email vote, Council approved the appointment of Richard Bass as EJP Editor, and Davar Khoshnevisan as EJP/ECP Managing Editor.

Electronic Council Meeting, March 4, 1999

Via an email vote, Council approved the appointment of Wilfrid Kendall as the new editor of the Electronic Communications in Probability (ECP).

August 1999

First Council Meeting, August 8, 1999

- Council voted on the motion that the IMS split the current LNMS into two series one for proceedings (to be published by the IMS) and one for the publication of Lecture Notes Monographs. The motion passed unanimously.
- For the new monograph series, the motion that IMS publish the new monograph series jointly with Springer-Verlag was narrowly passed.
- A motion was made to initiate non-binding negotiations with the Bernoulli Society to jointly publish lecture notes and monographs. This motion passed unanamously.
- The results of the IMS election were announced by Executive Secretary, Kathryn Roeder: the incoming president elect is Bernard Silverman, and the new Council members are Peter Donnelly, Robert Kass, Regina Liu, William Strawderman and Richard Tweedie. Donald Berry was elected to complete the remaining one year term of Bernard Silverman. The administrative officers made brief reports.

- President Fienberg reported on Renewals of Officers. Barry Arnold is the new Managing Editor of Statistics, Alicia Carriquiry is the incoming Executive Secretary, and Soren Asmundson is the incoming editor of Applied Probability. Searches to for a Managing Editor of Probability, and Editor of Annals of Probability and a Web Editor are in progress.
- Joel Greenhouse was nominated and approved as the new Editor of the Lecture Notes and Monograph Series.
- President Fienberg reported that the SIP committee selected Nancy Reid to give the Wald lectures, Mary Ellen Bock to give the Neyman lecture and Ioannis Karatzas, Mike West, Erwin Bolthausen, Andrew Gelman, Douglas Nychka, Michael Perlman, Aad vander Vaart, and Raymond Carroll to give the SIP lectures at the annual IMS meeting in Guanajuato, Mexico, in May 2000.

Business meeting, August 10, 1999

No actions taken.

Second Council meeting, August 11, 1999

- A motion was made to waive the basic dues for all students members who subscribed to one or more IMS journals (excluding the Bulletin) for a trial period of two years. Students would be offered journals priced at the reduced rate with The Bulletin offered free of charge along with membership. At the end of this trial period Council can determine if it wishes to continue with this policy indefinitely or return to our usual policy of offering students membership and journals at the usual reduced rate. This motion passed unanimously.
- A motion was made to raise dues for individual and joint subscription rates by \$5 and to raise reduced rates by \$2. The motion also included an increase in general subscription prices of \$10 for all journals except the Bulletin. The latter increase in journal prices applies only to non-members. This motion passed unanimously. To earmark the increased funds for outreach, a motion was made to set aside \$25,000 in the budget for development. This motion passed unanimously.
- The Council approved the following U.S. Postal Service Regulation:

Resolved: The scientific journals of the Institute of Mathematical Statistics are Statistical Science, The Annals of Statistics, The Annals of Probability, and The Annals of Applied Probability. The IMS Bulletin is the news organ of the Institute. Each individual member receives The IMS Bulletin and must elect to receive at least one of the four scientific journals. Members pay annual dues of \$65. An additional amount is added to the dues of the members depending on the scientific journal selected as follows: Statistical Science (\$15), The Annals of Applied Probability (\$20), The Annals of Statistics (\$30) or The Annals of Probability (\$25). Of the total dues paid, \$29 is allocated to The IMS Bulletin and the remaining amount is allocated equally among the scientific journals received.

• The Council discussed ground rules for email voting. The following procedure was recommended. 1. A proposal will be set before the Council with an announcement that voting will commence in about 2 weeks. 2. For the next 2 weeks discussion will take place via email. Although most of this discussion will naturally be shared with everyone on the Council, the President will make an effort to distribute this discussion in an organized manner just before the initiation of the voting process. 3. Finally, a formal motion will be distributed with an invitation to the Council to vote. Unless there is some urgency, the topics will be presented to Council at regular intervals. To stop a vote, Roberts rules of order will apply. If one person calls for a suspension and another person seconds this motion, the voting is called to a halt. It was also noted that as technologies advance we should investigate the feasibility of web based dialogues.

- The Council informally voted to establish an ad-hoc committee to discuss how to best invest the IMS reserves, about \$1.5 million. The duty of this committee is to provide Council with a list of options.
- Via Past-President Fienberg, Rick Durrett proposed a motion stating "The current editor of the Annals of Applied Probability shall be a member, but not the chair, of a 3 person committee to pick his/her successor." The motion did not pass.

Electronic Council meeting, November 16, 1999

Via an email vote, Council approved the appointment of Susan Holmes as the new IMS Web Editor, effective immediately. Her appointment ends in December, 2002.

Electronic Council Meeting, April 5, 2000

Via an email vote, Council approved the appointment of Susan Murphy as the new Program Secretary of the IMS for the period May, 2000 to August, 2003.

May, 2000

First Council Meeting, May 14, 2000

- The results of the election were announced by Executive Secretary Alicia Carriquiry: the incoming President is Iain Johnstone, and the new Council members are Peter Bickel, Wayne Fuller, Peter McCullagh, John Rice, and Jessical Utts. Their term expires in August, 2003.
- Treasurer Julia Norton reported that membership numbers continue to decline, but that student membership increased by about 400. Program Secretary Bruce Lindsay reported on the IMS sponsored and co-sponsored meetings held in 1999 and 2000, and provided a schedule of meetings to be held between May, 2000 and August, 2002.
- The Editors of the Annals of Statistics, James Berger and Hans Kunsch, reported that submission numbers are declining, and recent numbers of the Annals have had fewer pages than in the past. However, review times have also been declining, and this may provide an incentive for authors to sumbit to the Annals. The Managing Editor for Statistics, Barry Arnold, requested a change in the system currently in use to direct manuscripts from the editors to the managing editor. Paul Kelly and Elyse Gustafson, together with the Annals editors and the Managing Editor for Statistics will establish guidelines for directing manuscripts to the Managing Editor one at a time, rather than as an entire issue of the journal.
- The Committee to Select Editors proposed John Marden and Jon Wellner for Editors of the Annals of Statistics. Council vote in favor of the appointments was unanimous. Their term is January 1, 2001, to December 31, 2003.
- President Eaton reported that a Nominations Committee has been appointed, and also reported on the list of Special Invited Presentations for 2001.
- The Executive Committee presented a proposal to Council for re-structuring the Electronic Issues Committee. According to the proposal, the EIC's membership will include six members on three-year rotations, and three ex-officio members: the Web Editor, the Bulletin Editor, and a member of the Publications Committee. The Council approved the proposal by unanimous vote.
- A motion to close the IMS Business Office in Hayward, CA, and to outsource the membership activities to FASEB. The motion passed by unanimous vote, after extensive discussion.

Business meeting, May 15, 2000

No actions taken.

Second Council Meeting, May 16, 2000

- A motion to pursue negotiations with Project Euclid on a non-exclusive basis, and to appoint Chris Burdzy to be the IMS representative was passed by unanimous vote. When the proposed contract arrives, the Executive Committee is authorized to proceed, but must maintain Council informed of any activity.
- Treasurer Julia Norton presented an update on the 2001. A motion to approve the 2001 budget was passed by unanimous vote.
- The Council approved the following U.S. Postal Service Regulation:

First Council meeting, August 4, 2001

• President Iain Johnstone presented information on the mini-meetings program, to be funded by the development fund.:

IMS will provide funds, publicity and perhaps expertise to help promote one or two day scientific meetings organized by IMS members. The idea is that these meetings be easy to organize, and focused on topics of current interest. The format of the meeting should promote the intensive exchange of ideas and brainstorming. They are "local+" in the sense that some, but perhaps only a few, out of town participants would typically be involved.

IMS Level of support: For example, US\$1,500 for one day meeting, US\$3,000 for two day meeting. e.g. 2 out of town speakers for one day, or 4 for a two day event. [Organizers might obtain other funding, of course, but should stay at 2 days or less].

These meetings should be open rather than closed meetings, but the lack of substantial financial support and the short and focused duration means that they will likely have an informal, workshop flavor and not become large and unwieldy.
